- in the case of CREST members, by utilising the CREST electronic proxy appointment service in accordance with the procedures described in the CREST Manual; or
- if you are an institutional investor, you may be able to appoint a proxy electronically via the Proxymity platform, a process which has been agreed by the Company and approved by the Registrar. For further information regarding Proxymity, please go to www.proxymity.io; or
